NOTICE IS HEREBY GIVEN, in accordance with Idaho Code 63-1311A, that the Payette City Council will meet at 7:00 pm on July 6, 2021, at the Payette City Council Chambers, 700 Center Avenue, Payette, to consider public comment regarding the institution of new and/or increased municipal fees in excess of five percent (5%) for the Payette Pool, for the purpose of adjusting to operating expense of the facility.

RESOLUTION 2021-06

A RESOLUTION OF THE CITY OF PAYETTE, IDAHO, ADOPTING A SCHEDULE OF REVISED OR NEW FEES FOR SERVICES REGULARLY CHARGED AS SPECIFIED BY CITY CODE AND INCLUDED IN THE SCHEDULE SPECIFIED IN RESOLUTION 2020-05; AND PROVIDING FOR THE EFFECTIVE DATE OF ALL FEES.

WHEREAS, the City of Payette, Idaho (“City”) is a municipal corporation operating under the laws of the State of Idaho and is authorized to fix rates and charges to offset the costs of administration, operations and maintenance of various programs; and,

WHEREAS, Pursuant to Idaho Code Sections 63-1311 and 63-1311A regarding City fees for services and fee increases, a public hearing was held after which the Council considered input by the public; and,

WHEREAS, the Recreation Director has recommended a change in pool use fees to address and assist with the cost of operating the facility; pool fees have not been examined or raised since 2019; and,

WHEREAS, the City Council deems it advisable to adopt existing fees set by earlier ordinances and resolutions in one general fee resolution; and,

WHEREAS, the Council has determined that the revised fees included in this Resolution are appropriate and are reasonably related to the purpose for which such fees are charged.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE AS FOLLOWS:

1. That the fees set forth in Exhibit “A” attached hereto and made a part hereof, be in force and effect in all matters relating to fees from and after the 7th day of July, 2021
2. That this Resolution replaces Resolution 2020-05
3. City staff is directed to take all administrative actions necessary to implement the forgoing fee schedule.

Any resolution or any fee inconsistent with the provisions of this resolution is hereby repealed or superseded to the extent of such inconsistency.

This fee schedule shall be effective beginning July 7, 2021 and shall remain in force until revised by subsequent resolution of the Payette City Council.
