

ORDINANCE 1159

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, ANNEXING THAT REAL PROPERTY WHICH IS DESCRIBED IN SECTION 1; PROVIDING SEVERABILITY; REPEALER; EFFECTIVE DATE;

Be it ordained and resolved by the Mayor and City Council of the City of Payette, Idaho.

Section 1: That real property, belong to Eyvonne Nichols known as Parcel 2836, be annexed into the City of Payette, Idaho, which is real property more particularly described as follows:

Land in Recorder's Plat of Section 34, Township 9 North, Range 5 West, Boise Meridian, as per Plat in Book 2, Page 5, Plat Records, Payette County, Idaho:

The West half of Block 14 SAVE AND EXCEPTING the East 3 feet thereof, AND FURTHER EXCEPTING the South 296.9 feet of the West 150 feet.

Section 2: That said parcel shall be zoned A-Residential

Section 4: If any portion of this Ordinance is found to be unenforceable or unconstitutional for any reason, the remaining portion of this Ordinance shall remain in full force and effect.

Section 5: Any portions of any existing Ordinances which are in conflict with this Ordinance are hereby repealed insofar as the conflict exists.

Section 6: This Ordinance shall take effect and be in full force and effect after its adoption and publication as required by law.

BE IT ORDAINED AND RESOLVED THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS APPROVAL, PASSAGE, AND PUBLICATION AS REQUIRED BY LAW.

This Ordinance shall be in full force and effect on the 17th day of August, 1998.

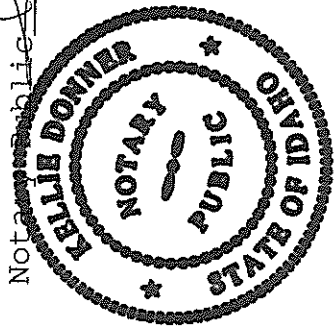
