

ORDINANCE 1536

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, AMENDING THE PAYETTE MUNICIPAL CODE SECTION 12.16.030: PARKS; HOURS WHEN CLOSED IN CHAPTER 12.16 PARKS AND PUBLIC PROPERTY, TO SET KIWANIS YOUTH LODGE AND PICKLEBALL COURT HOURS; SETTING AN EFFECTIVE DATE; ESTABLISHING SEVERABILITY; ESTABLISHING A REPEALER; ESTABLISHING A PENALTY.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF PAYETTE, IDAHO;

Section 1. Section 12.16.030 of the Payette Municipal Code, is hereby amended to read as follows:

- A. The public parks with the exception of Kiwanis Park as set below in B shall be closed to the public between dusk and dawn the following day for each and every day of the year, ~~unless otherwise authorized by law; and it is unlawful to be within any public park at a time it is closed.~~
- B. The Kiwanis Youth Lodge shall be open from dawn to 10:00pm.
- C. The Pickleball Courts shall be open from dawn to 10:00pm. Unless otherwise authorized by law; and it is unlawful to be within any public park, Kiwanis Youth Lodge, or Pickleball Court at a time it is closed.

Section 2. This Ordinance may be published in summary form allowed by Idaho Code.

Section 3. This Ordinance shall be in full force and effect immediately upon passage and publication as required by the laws of the State of Idaho.

Section 4. Any ordinances or resolutions which are in conflict with this Ordinance are hereby repealed, but only insofar as the conflict exists.

Section 5. If any portion of this Ordinance should be found to be unconstitutional or unenforceable for any reason, the remainder of the Ordinance shall be applied to effectuate the purposes of this Ordinance.

Section 7. Any violation of this Ordinance shall be a misdemeanor punishable by up to a \$1,000.00 fine and six months in the Payette County Jail, or both.

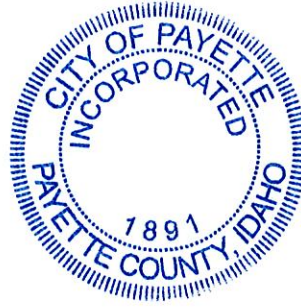

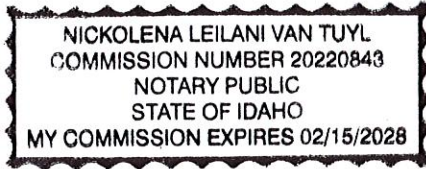
