**A RESOLUTION OF THE PAYETTE CITY COUNCIL  
ADJUSTING WATER & WASTEWATER FEE RATES**

WHEREAS, the City of Payette, Idaho (“City”) is a municipal corporation operating under the laws of the State of Idaho and is authorized to fix rates and charges and take such other actions incidental to the construction, management and operation of a municipal water system and a municipal sewer system pursuant to Title 50, Chapter 10, Idaho Code; and,

WHEREAS, in September 2021, the City Council last approved rate and fee increases to wastewater and water services; and


WHEREAS, it is the recommendation of the administration that the City implement the following increases to address the needs of the Capital Improvement Plan as identified in the 2020 Wastewater and Water Master Plans; and,
