## ORDINANCE NO 1922 By Councilman

AN ORDINANCE DEFINING JUNK YARDS AND AUTOMOBILE WRECK-ING YARDS AND PROVIDING AND REGULATING THE SAME, AND PROVIDING PENALTY FOR VIOLATION OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF PAYETTE, IDAHO:

Section 1.-- JUNK YARD DEFINED -- A Junk yard, within the meaning of this ordinance, shall be any establishment for business engaged in the buying, selling, trading or dealing in junk, scrap, metals or salvage materials of any kind.

SEction 2. -- AUTOMOBILE WRECKING YARD DEFINED -- An Automobile Wrecking Yard, within the meaning of this ordinance shall be any business establishment engaged principally in the buying and selling of used or wrecked automobiles for the purpose of dismantling the same and selling the parts therefrom.

Section 3.-- From and after the passage and approval of this ordinance, it shall be unlawful for any person or persons to operate a Junk Yard or Automobile Wrecking Yard within the City of Payette, Idaho, without first having applied for and received a license from the City of Payette so to do, and paying a license fee therefor.

Section 4. -- Applications for licenses to conduct junk yards or automobile wrecking yards shall be made in writing to the City Clerk, and licenses therefor shall be granted only upon the approval of the City Council of the City of Payette, Idaho.

Section 5.-- From and after the passage and approval of this ordinance, no junk yard or automobile wrecking yard shall be conducted, operated or maintained within any residential district of the City of Payette, Idaho; the term "residential district", within the meaning of this ordinance, is taken to include all that portion of the City of Payette, Idaho, lying South of 3rd Avenue South; and that portion of said city lying North of 3rd avenue North; that portion of said city lying East of 9th Street; and that portion of said city lying West of 6th Street.

Section 7. All persons conducting junk yards or automobile wrecking yards within the meaning of this ordinance shall keep a record of names and addresses of all persons from whom they purchase any of the materials dealt in, a list of the particular articles purchased, together with the date of the purchase and the amount paid therefor. This record shall be kept in a book set aside for that purpose only, and shall be open to the inspection of the Chief of

Police of the City of Payette, and to the Sheriff of the County of Payette, State of Idaho, upon demand; failure to keep such record by any junk yard or automobile wrecking yard shall constitute a misdemeanor and shall be punishable as hereinafter provided and shall be ground for revocation of the license of the operator of such junk yard or automobile wrecking yard.

Section 8.-- Any person who shall violate any provision of this ordinance shall be guilty of a misdemeanor and shall be punished therefor as provided by the ordinances of the City of Payette, Idaho.

This ordinance shall be in full force and effect from and after its passage, approval and publication.
