AN ORDINANCE AMENDING SECTION 24 OF ORDINANCE 94, ENTITLED "AN ORDINANCE REGULATING AND CONTROLLING THE WATER WORKS OF THE CITY OF PAYETTE, AND PROVIDING FOR A SUPERINTENDENT OF THE WATER WORKS, THE PRICE OF WATER, RELATING TO PUNISHMENTS OF OFFENSES IN RELATION THEREOF AND REPEALING ORDINANCE NO. 68 ENTITLED "AN ORDINANCE FIXING, REGULATING AND CONTROLLING THE USE AND PRICE OF WATER AND PROVIDING FOR A SUPERINTENDENT OF THE WATER WORKS OF THE CITY OF PAYETTE, IDAHO, AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

Be it ordained by the Mayor and Council of the City of Payette:
Section 1. That section ~~24~~ 24 of ordinance No. 94 of the City of Payette, Idaho, entitled "An ordinance regulating and controlling the water works of the City of Payette, and providing for a superintendent of the water works, the price of water, relating to the punishment of offenses in relation thereto and repealing ordinance No. 68 entitled an ordinance ~~fixing~~ fixing, regulating and controlling the use and price of the water and providing for a superintendent of the water works of the City of Payette, Idaho, and providing penalties for violation thereof," passed by the Mayor and Council of the said city and approved by the Mayor thereof on the 19th day of July, 1907, be and the same is hereby amended to read as follows:

Section 24. The following shall be the rates for the use of the City water, viz: When the amount is ten thousand gallons per month or any amount in excess thereof, per one thousand gallons, ten cents; in all cases where the amount does not exceed ten thousand gallons, a minimum charge of one dollar shall be paid.
