ORDINANCE #1445

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, VACATING AN EIGHT FOOT PORTION OF A PUBLIC EASEMENT LOCATED ON A PARCEL OF LAND SITUATE ON THE SOUTH SIDE OF THE T.J. LLOYD SUBDIVISION, BLOCK 6, LOTS 1, 2 AND 3 AND BLOCK 5, LOTS 1 & 2 WITHIN THE CITY OF PAYETTE; PROVIDING FOR EXECUTION OF A QUITCLAIM DEED BY THE MAYOR CONVEYING TITLE OF THE VACATED PROPERTY TO THE ADJOINING LANDOWNERS; RESERVING UTILITY EASEMENTS; PROVIDING AN EFFECTIVE DATE: PROVIDING FOR PUBLICATION BY SUMMARY.

WHEREAS, the Payette City Council has determined, and hereby finds, that the 8 foot public easement that lies South and adjacent to Block 6: Lots 1, 2 and 3 & Block 5: Lots 1 and 2 of the T.J. Lloyd Subdivision is no longer necessary for the public interest; and

WHEREAS, the Payette City Council finds it appropriate to vacate the South 8 feet of T.J. Lloyd Subdivision, Block 6, Lots 1, 2 and 3 and Block 5, Lots 1 and 2.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE, IDAHO:

Section 1: The City of Payette hereby vacates all that portion of the alley lying South of and adjacent to the T.J. Lloyd Subdivision, Block 6: Lots 1, 2 and 3 and Block 5: Lots 1 and 2.

- Section 2: The City reserves any utility easements which may be necessary or convenient for the distribution or delivery of public utilities.
- Section 3: The Mayor of the City of Payette is hereby authorized to execute and deliver quitclaim deeds on behalf of the City of Payette, conveying the property to the adjoining property owner of record pursuant to Idaho Code Section 50-3II.
- Section 4: This ordinance shall be in full force and effect from and after its passage and publication according to law.

Section 5: This ordinance may be published in summary form in accordance with the statutes of the State of Idaho.
